# About SCERA

Sustainability and Conservation Education for Rural Areas (SCERA) is a conservation and environmental education non-government organisation (NGO) committed to the conservation of Nigeria's biological diversity, by identifying environmental problems through research and providing evidence-based sustainable solutions while advocating for environmentally friendly actions. Our objectives are: (1) To identify and investigate environmental problems through research so as to understand the underlying factors driving environmental change and negative behaviours. (2) To identify and provide evidence-based sustainable solutions while advocating for environmentally friendly actions. (3) To tackle environmental problems through capacity building and rural empowerment. (4) To promote the involvement of local communities in environmental communication and biodiversity conservation. (5) Establishing strong collaborations for biodiversity conservation.

Our mission is to promote biodiversity conservation in Nigeria using science-based solutions, through sustainable partnerships and public empowerment, working with people closest to nature.

## The project

Of Nigeria's total forest area of 90,410 km<sup>2</sup>, less than 30% is under some form of protection. The country's diverse ecosystems range from freshwater swamp forest, mangrove forest and coastal vegetation, lowland forest, savannah, to montane ecosystems and hosts a rich variety of species of fauna and flora, including over 7,000 plant species, about 20,000 insects and 1,000 bird species, more than 1,000 fish species, close to 250 mammals and over 120 reptiles. A

number of these species have become threatened and remaining populations depend on protected areas for their survival. However, the country has suffered from severe environmental threats that have led to the loss of biodiversity driven by large scale forest conversion, unsustainable forest management and harvest of natural resources, pollution, invasive alien species and climate change.

SCERA has secured funding from the Critical Ecosystem Partnership Fund (CEPF) for the mainstreaming of biodiversity in national policies and environmental practices. The Project will focus on generating much needed information on biodiversity and will support the mainstreaming of biodiversity values in environmental practices of the private and public sectors. Part of the project will be implemented in the Okomu National Park and surrounding forests located in Edo State. The projectwill address data gaps on globally threatened and endemic species, including the Nigeria-Cameroun Chimpanzee, White-throated Guenon, African forest elephant, Grey Parrot etc. and raise awareness among the general public on the importance and values of biodiversity and the impacts of biodiversity and forest loss, on human health and well-being (e.g. link between forest loss and zoonotic diseases), especially in light of the COVID19 pandemic.

SCERA will work closely with partners and stakeholders in the conservation arena, establishing partnerships and building capacity for biodiversity and forest protection while providing the tools needed for long-term conservation and management of some of Nigeria's most threatened species and habitats.

## **Purpose**

We are looking for a dynamic and committed conservationist to coordinate implementation of project activities at the Okomu National Park, working with the Okomu National Park Management and local, state and national stakeholders. The successful candidate will work within a multi-disciplinary team, leading a small team at the field site and reporting to and working closely with technical and administrative teams at SCERA's offices in Jos and Abuja.

#### Specific responsibilities:

#### **Biodiversity Stakeholders Coordination**

- In collaboration with ONP partners, support the establishment of a Biodiversity Stakeholders Platform (BSP);
  - Working with the Okomu Park Management, partners and local communities, and based on an agreed criteria, support the selection process for community participants on the CEPF project
  - Organise quarterly meetings of the BSP and providing secretarial support where needed

- Facilitate the development of a terms of reference (TOR) for the BSP, including the roles and responsibilities of members, structure of the group, a sustainable financing plan etc.
- Facilitate the development of a grievance redress mechanism under the BSP in line with the procedure outlined in SCERA's process framework for stakeholder engagement
- Support the rolling out of environmental guidelines developed under the CEPF project, through the BSP

# **Project Coordination**

- Co-ordinate and lead on SCERA's activities in the ONP:
  - Supervise project staff and interns and ensuring that activities are carried out in line with agreed budget and timelines
  - Produce narrative and financial reports and provide other relevant materials/products and information required for M & E purposes to the Technical Programme Coordinator (TPC)
  - Schedule regular update meetings with the TPC and the Programme Operations Coordinator (POC)
  - Supported by the SCERA Project officer ONP, co-ordinate logistics for research teams and consultants, ensuring smooth running of planned activities

- In collaboration with the Head of Research at the ONP, co-ordinate research activities implemented by SCERA and support implementation of socioeconomic and/or biodiversity related research and monitoring in line with their expertise
